

## **APPLICATION FORM TO DATA CONTROLLER**

### **A. General Statements**

Everyone can submit an application to Piri Medya AŞ in its capacity as data controller in accordance with Article 11 of Law no. 6698 on the Protection of Personal Data (“LPPD”), and have the right to request the following:

- a) Learn whether their personal data has been processed,
- b) Request information about the processing of their personal data,
- c) Learn the purpose for which their personal data has been processed and whether they are used in accordance with these purposes,
- d) Find out the identity of third parties in the country or abroad to whom their personal data has been transferred,
- e) Request the correction of their personal data in case of incomplete or incorrect processing,
- f) Request the erasure or destruction of their personal data in the event that the reasons requiring its processing are removed, despite the fact that it has been processed in accordance with Article 7 of the LPPD and other relevant regulations, and to
- g) Request to be notified of the transaction made within the scope of subparagraphs (e) and (f) to third parties to whom their personal data has been transferred,
- h) Object to an unfavorable result following the processing of data exclusively through the analysis of automatic systems,
- i) And claim damages if they incur losses due to unlawful processing of their personal data.

### **B. Processing of Personal Data with Respect to Application**

Through the Application Form to the Data Controller, limited and relevant personal data (Name, Surname, Turkish Republic Identity Number, Passport Number, Phone Number, E-Mail, Address, Signature) are processed in order to identify the applicant and manage the application. The personal data in question can be shared with the relevant units and authorized institutions/organizations, depending on the nature of the application request.
